| Charter Amendment<br>Addressing the Salaries<br>of City Commissioners                 | Shall the Charter of the City of Tallahassee be amended to provide that members of the City Commission be paid an annual salary equal to the annual salary set by state law for members of the Board of County Commissioners of Leon County, Florida?YESNO   | The current Charter provides for the salaries of City<br>Commissioners other than the mayor to be set at half of the<br>Leon County Commissioners. The formula for the mayor's<br>salary, currently set as equal to County Commissioners, would<br>remain unchanged.  |
| Charter Amendment<br>Expanding Jurisdiction of<br>the Independent Ethics<br>Board     | Shall the Charter of the City of Tallahassee be amended to provide that the Tallahassee Independent Ethics Board has jurisdiction over members of the City Commission when they are serving as board members of outside governmental agencies by reason of their city commission roles?YESNO                     | The current Charter provides the Independent Ethics Board jurisdiction over City Commissioners, but doesn't explicitly say that this jurisdiction applies when they sit as members of external governmental bodies, such as the Blueprint Intergovernmental Agency and the Community Redevelopment Agency. This would clarify that this jurisdiction applies to Commissioners in whatever role they serve as elected officials.                                 |
| Charter Amendment to<br>Resolve Two-Candidate<br>Elections at the General<br>Election | Shall the Charter of the City of Tallahassee be amended to provide that if only two candidates, neither of whom is a write-in candidate, qualify for the same seat on the City Commission, the names of those candidates will appear on the general election ballot instead of the primary election ballot?YESNO | Currently, two-candidate races are decided by the results of the Primary Election in August. This amendment will allow such races to be decided by the generally larger turnout November election, leaving less time between the election and the assumption of office.   |
| Charter Amendment to<br>Provide for Periodic<br>Review of the Charter                 | Shall the Charter of the City of Tallahassee be amended to require the City Commission to convene a charter review committee and conduct a review of the charter every ten years, beginning in June 2033?YESNO   | Although charter reviews have been conducted in the past, this amendment if passed will be the first time that a regular schedule for charter reviews will be established.  |
| Charter Amendment Defining the Role of the Inspector General                          | Shall the Charter of the City of Tallahassee be amended to define the role of the Inspector General by charter rather than by ordinance?YESNO  | The intent of this amendment is to establish greater independence to the Office of Inspector General, so that no City Commission can abolish the office by ordinance. The amendment will also require a super-majority vote (currently involving at least four of the five commissioners) to dismiss any holder of that office. Such dismissal must be for cause and the Inspector General must be given the opportunity to rebut this cause in a public forum. |
